



Hexavalent Chromium (Cr(VI)) Testing Flow Chart







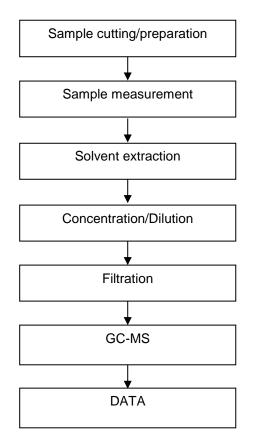



TBBP-A Testing Flow Chart







Chlorinated Paraffin Testing Flow Chart









Red phosphorus Testing Flow Chart




